

UNIVERSITY PLANNING, DESIGN & CONSTRUCTION PROJECT MANAGEMENT

The University of Toronto (the "University") utilizes a Request for Supplier Qualification ("RFSQ") as an invitation to qualify to participate, by way of invitational second stage competitive processes, in construction projects at the University as contractors entered on to a prequalification list (the "Prequalified List). The University will use the Prequalified List to select contractors that supply the following services to bid as prime contractor on the University's various construction projects:

- 1. General Contractor
- 2. Electrical Contractor
- 3. Mechanical HVAC
- 4. Mechanical Plumbing
- 5. Mechanical Integrated Automation
- 6. Mechanical Fire Suppression
- 7. Thermal/Moisture Protection and Roofing
- 8. Demolition
- 9. Restoration
- 10. Asbestos Abatement

The University will prequalify contractors using the electronic posting site **BIDDINGO.COM** (http://www.biddingo.com/uoft). - 1. Log in through your Biddingo account to the University of Toronto Landing Page at www.biddingo.com/uoft.
- 2. Click Supplier Pre-Qualification.
- 3. Complete the registration and payment process.
- 4. Download all the required documents and **complete the on-screen Corporate Information forms**.
- Complete the Appendices and deliver along with all other required forms to the University of Toronto.

The University has structured the RFSQ and Prequalification process to be compliant with the principles of transparency, openness and fairness. To be transparent, the University strives to remain consistently impartial and to provide clear, understandable rules and procedures that identify how respondents will be evaluated and the requirements for success and failure. To be open, the University has made this process open to the public. To be fair, the University has laid out objective criteria which are in accordance with the needs of the University.

The RFSQ and Prequalification process does not constitute an offer of any kind by the University to any or all of the respondents. The University makes no guarantee of the value or volume of work to be assigned to the prequalified respondents. Any agreement entered into pursuant to an invitational second-

stage competitive process will not be an exclusive contract for the provision of the described deliverables beyond that particular agreement.

THE UNIVERSITY DISCLAIMS ANY OBLIGATION TO CALL ON ANY SUPPLIER TO PROVIDE GOODS OR SERVICES AS A RESULT OF PREQUALIFICATION. THE UNIVERSITY MAY CONTRACT WITH OTHERS FOR THE SAME OR SIMILAR DELIVERABLES TO THOSE DESCRIBED IN THIS RFSQ OR MAY OBTAIN THE SAME OR SIMILAR DELIVERABLES INTERNALLY. THE UNIVERSITY RESERVES THE RIGHT TO RE-ISSUE THIS RFSQ AS IT MAY DEEM NECESSARY.

GENERAL LABOUR CONDITIONS

Any part of the Work performed by the prequalified contractor on behalf of the University that falls under the provisions of any collective agreements by which the University is bound, or which the University is contractually required to apply to any given project, shall in each case be performed by employees covered by the applicable collective agreement. Without limiting the generality of the foregoing, such collective agreements include:

- Where applicable, the current provincial agreement covering construction work in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario between the Electrical Trade Bargaining Agency of the Electrical Contractors' Association of Ontario and the International Brotherhood of Electrical Workers and the IBEW Construction Council of Ontario, and its affiliated locals, including IBEW Local 353;
- 2. Where applicable, the current provincial agreement covering construction work in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario between the Mechanical Contractors Association of Ontario and the Ontario Pipe Trades Council, and its affiliated locals, including UA Local 46;
- Where applicable, the current provincial agreement covering construction work in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario between the Canadian Automatic Sprinkler Association and the United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada, and its affiliated local, UA Local 853;
- 4. Where applicable, the current provincial agreement covering construction work in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario between a council of employers' associations consisting of the Ontario Painting Contractors Association, the Acoustical Association of Ontario and the Interior Systems Contractors Association of Ontario and the International Union of Painters and Allied Trades and the Ontario Council of the International Union of Painters and Allied Trades, and its affiliated locals, including IUPAT Local 557; and
- 5. Where applicable, the current provincial agreement covering construction work in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario between the Carpenters' Employer Bargaining Agency and the Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America, and its affiliated locals including Carpenters Local 27 and Carpenters Local 675.

General contractors working on projects at all University campuses with a value below \$150K and above \$700K must be bound to the provincial agreement between the Carpenters' Employer Bargaining Agency and the Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America, and its affiliated locals, including Carpenters Local 27 and Carpenters Local 675.

These General Labour Conditions shall apply to each prequalified contractor and any of its subcontractors and the prequalified contractor shall include these General Labour Conditions, with necessary changes, in each of its contracts with subcontractors for any part of the Project.

The prequalified contractor shall indemnify and save the University harmless from and against all loss, claim, expense or damage suffered by the University arising from the failure of the prequalified contractor or any of its subcontractors to comply with the requirements of these General Labour Conditions. This indemnity is in addition to, and not limited by, any subsequent indemnification provided by the prequalified contractor.
